PROVISIONS COMMON TO ALL LIFTING EQUIPMENT

ORDER DEADLINES

Pursuant to the social contract, tooling orders must be placed :

- ☐ The day before by 5 p.m. for the following day
- ☐ Friday before 5 p.m. for weekends and the following Monday (in the event of force majeure (damage, breakdown, weather), this condition may be revised).

If these deadlines are not met, a surcharge of 50% of the cost of the service will be applied.

All changes to orders must be sent to the order desk by 11.30 a.m. on the same day for the afternoon.

In the event of an incorrectly sized machine order that requires teams to be reorganised and/or a shift to on-call duty, a surcharge will be applied :

- ☐ 25% of the cost of the service from Monday to Saturday
- ☐ 50% of the cost of the service on Sundays

EXPECTATIONS

If the equipment ordered is not used due to bad weather (inability to drive the equipment), ship delays or operations completed before the end of the working period, the discount mentioned in the price list specific to each piece of equipment will be applied.

This reduction is applied by the port operator pro rata to the waiting time supported by the submission of the ship's time sheet countersigned by the stevedore and the ship's captain.

This provision does not apply to orders for individual isolated hours between 6 a.m. and 8 p.m.

BREAKDOWNS OF LIFTING EQUIPMENT

In the event of a continuous breakdown lasting over an hour, the machine will not be invoiced for the downtime.

In the event of discontinuous breakdowns lasting over an hour out of an ordered four-hour shift, or more than one hour and three quarters out of an ordered seven-hour shift, the port operator may decide not to charge for the equipment, depending on the circumstances of the breakdowns and their impact on the handling operations at the port of call.

To avoid being billed for equipment breakdowns, the ship's time sheet, countersigned by the stevedore and the ship's captain, must be submitted to the port operator.

FORFEIT CLAUSE
